MISDIRECTED FUNDS RECOVERY

Our insured transferred \$1,875,059.89 to a fraudulent account based on an email they received that purported to be from a client. Months later, after failed attempts to recover through their bank, the insured contacted TMHCC. We were able to leverage law enforcement and banking contacts to recover over \$900,000 of those misdirected funds for the insured. The recovery, plus the \$250,000 in coverage afforded, helped to minimize the insured's losses as much as possible.

THANKSGIVING PAYMENT

Our Cyber Incident Management Team was assisting an insured with a negotiation into Thanksgiving break, ultimately requiring payment while offices were closed. Due to TMHCC's Cyber Incident Management Team and Cyber & Tech Claims Team's real-time availability, even on Thanksgiving Day, we were able to obtain internal approval to make a large ransom payment so that the insured could restore operations by the following Monday to minimize business interruption.

VENDOR AS "WHITE HAT" HACKER

While assisting our insured with response to an incident, our Cyber Incident Management Team vendor discovered a Threat Actor left access to the file sharing site used to steal and host the insured's data. This allowed the Incident Response firm to use the Threat Actor's credentials to access the file sharing site and delete the insured's data, minimizing the data exposure and keeping the data out of the hands of criminals.
