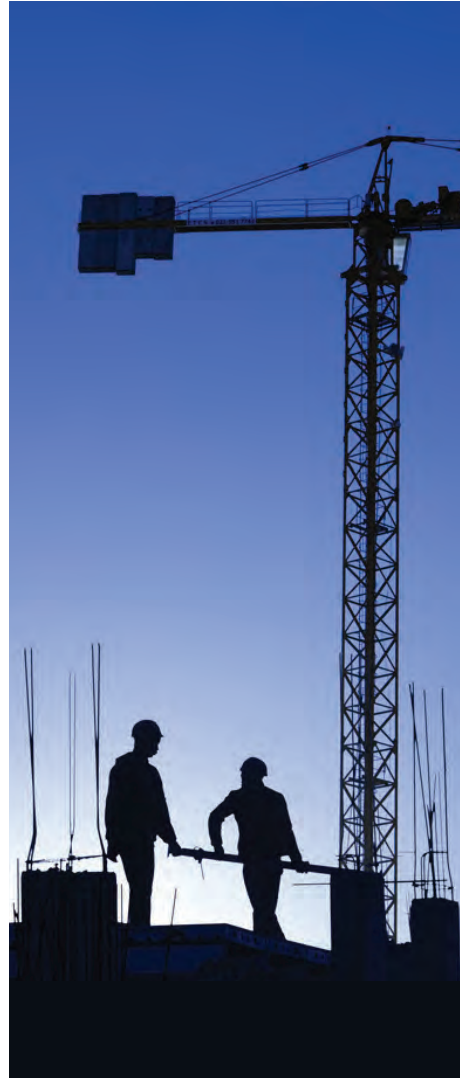


# Architects & Engineers and Contractors Professional Liability Risk Management & Pre-Claim Assistance Services
